

Not illustrated. 1914 Excerpt: . . . aim to maintain prices fixed with a view of allowing only a fair return to all who in the chain of distribution ultimately serve the customer. It is not a question of legalizing combinations which would prevent competition, but it is a question of allowing each individual manufacturer to fix the retail prices on products which are peculiarly his own. It would not permit an agreement between the manufacturers of similar products, which might thus work to the public harm. Competition at the source would remain entirely free and open, and for that very reason the public would be protected in the matter of having reasonable prices. Every manufacturer would know that his price to the consumer would have to be right and afford only a reasonable profit to all concerned; for otherwise, his competing manufacturers would surely undersell him. So long as the source of supply is unhindered and not permitted to combine, the interests of the public are safeguarded. The legislative committee also sent a letter to the various organizations of retail merchants in this section of the state, urging them to endorse the bill. The Cincinnati branch of the American Pharmaceutical Association will hold its next meeting at the Lloyd Library, May 12th; and it is likely that this will be the last meeting of the season.
