The potential delay of contract award or performance triggered by a GAO protest, coupled with the increasing number of GAO protests, has also prompted concerns about the impact of protests upon agency operations, especially in the Department of Defense. Additionally, the 111th Congress enacted legislation (P.L. 111-383) extending GAO s jurisdiction over protests of the issuance by defense agencies of task or delivery orders valued in excess of \$10 million. Members of the 112th Congress have introduced legislation (H.R. 899, S. 498) that would extend GAO s jurisdiction over similar protests involving the orders of civilian agencies, which is currently scheduled to expire in May 2011. GAO, the contracting agencies, and the Court of Federal Claims all have authority to hear bid protests; however, GAO hears more protests annually than the Court of Federal Claims, the only other forum for which data are readily available. GAO s bid-protest process includes some unique features--most notably, the stay of contract award or performance commonly triggered by a GAO protest--that make GAO a .
